**Superintendent Recommendations**

Mr. Tim Wilder stated May 13<sup>th</sup> is scheduled as a Work Shop and we need to do it as a Special meeting for personnel. At the 22<sup>nd</sup> meeting we will non-renew support employees and May 13<sup>th</sup> we will look at certified employees.

Mr. Chris Shaw made a presentation to the Board talking about 21<sup>st</sup> Century Schools, going from textbooks to the digital textbooks-EBooks, using iPads, electronic devices, and the One to One Initiative. The first process would be to pilot a program allowing the use of cell phones during non-instructional time. They were allowed to use the cell phones before school, during class change, during break, during lunch but not in the classroom when instruction was taking place. Discussion was held regarding the policy, bringing back the pros and cons, taking pictures of tests, texting while taking a test, studies were done, discipline issues went down, the classroom teacher is the one that controls the instruction in the classroom, filter system, waiving or amending the policy, and not doing it in the middle and elementary schools. Mr. Jere Segrest recommended because it is an established policy to run it by the policy committee before the Board takes any action for both high schools stating there could be problems and you would be usurping the policy committee in its entirety by doing it even on a temporary basis. I think it might be wise to make sure that is done before the Board takes any action. Mr. Tim Wilder stated we want to make sure it is done right and have the committee hear the situation and by the 22<sup>nd</sup> have an opinion from the committee and ready for this Board to look at.

Mr. Ben Armstrong made a motion seconded by Mr. Franklin Jones to refer it to the Policy Committee. The motion carried. Voting was as follows: "YEA" – Jones, Woodall, Addison, Guilford, Armstrong. "NAY" – None. "ABSTAIN" – None.

Dr. Harry Wayne Parrish stated we will bring it back on the 22<sup>nd</sup>. Dr. Dell Goodwin stated the policy committee would meet, then make a recommendation back to the Board and the Board would have to vote on it as your policy. That would be to recommend that you pilot it through the rest of this school year.

Mr. Chris Shaw stated Ethan Holland was the 6A State award winner for achievement at the Bryant Jordan Scholarship Award Banquet winning close to \$6,000 in scholarships. Casey Cooper was the Region winner for academics for this area.

Mr. Tim Wilder and Mr. Chris Shaw announced the following:

1. Ms. Barbie Nelson is one of the finalists for Secondary Teacher of the Year and Tracy Pruitt is at the Elementary Level. Barbie and Tracy are also finalists in the Jacksonville State Hall of Fame.
2. Northview's baseball team won the area baseball championship last night.
3. Ryan Richards' was the WTVY Teacher of the month.
4. We are going to get the middle school committee together again and have some recommendations for you hopefully by May.

Mr. Tim Wilder stated we are losing two people, Larry and Dell, and it will be a big loss for Dothan City Schools. Also, as a member of the Dothan Education Foundation Lavonda Gosselin who heads up our Adopt A School Program surprised us with her letter of resignation. When she started there may have been 4 adopters and now there are 120+ with every school represented, and there are faith based organizations representing every school. Lavonda from me and the Dothan City Board of Education you will be missed tremendously.

Dr. Dell Goodwin stated we will go live with Kelly Services this week. It is just for our certified employees.
