Mr. Tim Wilder stated I want to commend Dell on the job that she has done. This has been an unbelievable task in getting this budget to her as late as we did and for her to have done as you have heard hundreds of literally movement from transfers, supplements, hiring and there are still some she is waiting on me to make some calls on that and get some recommendations to you all that changes every day. I want to thank her for a great job of this. It is a hard job right now and I know she will be glad when school starts.

Superintendent Recommendations

Reauthorization of (4) ISS Instructional Positions - 1 Dothan High School, 1 Northview High School, 1 Girard Middle School and 1 Honeysuckle Middle School: Mr. Tim Wilder stated I sent you an email talking about this that it would be coming out of our general operating fund or at least our fund balance money. As you know we cut all those 18 non-instructional aides and it presented problems. We have four schools to high schools and two of our middle schools that rely on In School Suspension as a deterrent for bad behavior and also the consequence for bad behavior and I certainly support that and without these people being put back it is going to be very difficult to maintain any kind of order in terms of discipline unless we have that. My recommendation, thank you Allyson Morgan for finding some money as late as today, is that these four positions if granted by the Board will be paid out of funds not in our general operating funds but risk management funds released as late as today by the Alabama Legislature. In the past we have had to give about 20% of the grant to community partnerships and this year the language is gone it says that. It will now pay for two of our aides and also High Hopes in the past the only allowable use was for graduation exam remediation and now restrictions have been lifted and can be used in other at risk areas. Our allocation is increased by \$35,000 in that area which will pay for an aide. Also, in our Children's First Grant one additional aide will be paid for with this. This is intended for behaviorally and academically at risk students. Thanks for her hard work today we will not have to take this out of our general operating fund.

Mr. Franklin Jones made a motion seconded by Mrs. Brenda Guilford to approve Item 3.1 Reauthorization of (4) ISS Instructional Positions: 1 Dothan High School, 1 Northview High School, 1 Girard Middle School and 1 Honeysuckle Middle School as presented and as recommended by the Superintendent. The motion carried unanimously. Voting was as follows: "YEA" — Jones, Woodall, Addison, Guilford, Armstrong, Maddox. "NAY" — None. "ABSTAIN" — None.

Mr. Tim Wilder stated also on 3.1 understand too we are still dealing with, as I have talked with several of you Board Members, prioritizing non-instructional aides. There is still an issue with right now with our two high school bands. I have been receiving emails and answering emails and we are continuing to look at ways to fund those. As you know, the Board picked those up a couple of years ago and started paying for aides for band during the day and I am getting some information on the history of those aides. At this point, I do not have a recommendation to the Board to keep those however we are looking for grant opportunities to keep those aides. Also, another area is Physical Education as you know without these non-instructional aides it leaves some of elementary classes sometimes with 60/70 kids and it may present a safety risk so I want to sit down with those Principals to see how they plan on covering it and if they do not have a means to cover that we also need to look for some grant opportunities. As you can see it is now getting into the classrooms and starting to affect students and before it affects the safety of those students I think we need to look at all things to correct that. My first step was to find the money for these ISS aides and we will begin to look for money for band as well as PE aides a little later.

Request to advertise for Architectural Services – Parking Lot Central Office and Girls/Boys Locker Facilities at Dothan High School: Mr. Tim Wilder stated these are two different projects for requests to advertise for Architectural services. Mr. Manuel and I were talking earlier about the Girls/Boys Locker facilities and I met with you about that a little bit. There is some history behind and I will let Mr. Manuel talk about that. The other is the parking lot at Central Office and I will also let Mr. Manuel talk about the funds for that. I know we do have those and the idea as you can tell and through media coverage we have done some changes and we would like to make that entrance off Dusy Street and pave that area where it is all grass, put some nice stripes there and make it a nice parking area for people to come in that door so they will come right into the reception area first. Mr. Mike Manuel stated the parking lot

request is to advertise for Architectural service and I have already been in discussion with the City and it looks like we will be able to piggy back off of their asphalt bid they have which we have done in the past and we have done at other schools for basically we will pay the cost of labor but I do need to have an architect to design the plans for that because it will be some relocation of utilities there. We will probably have to remove the tree although I am getting lobby to keep the tree. Paving that will be some draining issues with the slope of the land to make sure the water flows off properly but I feel like we will be able to piggy back off the City's bid on asphalt. I have already spoken to Mr. Corbin in public works and we have done that in the past. That money would come out of Capital Outlay not out of the general fund. The estimate on that is about \$50,000. Dr. Harry Wayne Parrish asked about the Girls/Boys Locker facility. Mr. Mike Manuel stated there are two allocations from the State on that one from Senator Smith giving \$25,000 for the boy's baseball team to have a locker facility at the end of their batting cage and then Representative Lewis had given another allocation of about \$35,000 to add a girl's locker facility at the other end of the batting cage. I spoke with Mr. Humphrey and Coach White and got their input about what they want to see and that is their wishes to have a girl's and a boy's locker facility for the baseball and softball teams. We do have monies from the State for that. Dr. Harry Wayne Parrish stated I know you said the names but I am just repeating it, Dothan High. Mr. Mike Manuel stated the money that Senator Smith for that locker facility is actually dedicated to Coach Collins because of his long term commitment to Dothan High School and the baseball team over there. Dr. Harry Wayne Parrish stated I think everybody knows he is a tremendous guy and everybody thinks the world of him. Mr. Tim Wilder stated I want to make sure the Board is comfortable with this right now we are requesting to advertise for architectural services to look at what the architect draws up. If we get a quote that is something we can live with and the Board wants to continue with this if you will give us permission to at least start advertising to get an architect in here to look at how we would do those two projects.

Mr. Ben Armstrong made a motion seconded by Mrs. Brenda Guilford to approve Item 3.2 Request to advertise for Architectural Services – Parking Lot Central Office and Girls/Boys Locker Facilities at Dothan High School as presented and as recommended by the Superintendent.

Mr. Charles Woodall stated I would like to make a comment. I am going to have a hard time voting positive on that because we voted last week to take over \$700,000 out of Capital Outlay. I understand that we are not spending any money tonight but you know \$50,000 would put a custodian back at one of the high schools if it was needed or pay for one of these aides in PE classes. I just want to make that comment. Mr. Tim Wilder stated if you separate the two at least and if you do not want to do one or the other because the other is paid for by the Legislatures. Mr. Franklin Jones stated I would like that. Mr. Charles Woodall stated I certainly the new configuration on that but I think that is something we should do down the road. I am just not prepared to vote for that tonight.

Mr. Ben Armstrong made a motion to rescind his motion seconded by Mrs. Brenda Guilford.

Mr. Ben Armstrong made a motion seconded by Mrs. Brenda Guilford to approve the request to advertise for architectural services for the Girls/Boys Locker Facility at Dothan High School as presented and as recommended by the Superintendent. The motion carried unanimously. Voting was as follows: "YEA" – Jones, Woodall, Addison, Guilford, Armstrong, Maddox. "NAY" – None. "ABSTAIN" – None.

Mr. Tim Wilder stated Mr. Chairman I still recommend still at least if you will entertain the option to, I did hear Mr. Woodall loud and clear, if the Board will allow us to go on with the architect for the parking lot and take a vote on that as well.

Mr. Chris Maddox stated that is nothing more than getting the bids right. Mr. Mike Manuel stated we would bring back the architects for you to interview them and make a selection and we could at least have plans designed and at that point have construction bids and the Board would have at least two more opportunities to review this. Mr. Tim Wilder stated those bids are probably good for a little while so the Board would stop short of paying for that project but at least we could get an architect in to talk with you about how it would be laid out. That is all I am asking for at this point.

Mr. Ben Armstrong made a motion seconded by Mr. Chris Maddox to approve the request to advertise for architectural services for the Parking at Central Office as presented and as recommended by the Superintendent. The motion carried. Voting was as follows: "YEA" – Jones, Addison, Guilford, Armstrong, Maddox. "NAY" –Woodall. "ABSTAIN" – None.

Mrs. Brenda Guilford stated I want to thank Mr. Woodall for bringing it to our attention this evening because again here we are just getting this and when I came in I did not have time to look at this. Again I want to state the importance of maybe getting these things so that we can really look at them. If he had not brought it to my attention I might have voted for it. Mr. Tim Wilder stated this is not money that you are going to approve the project it is just to advertise. I appreciate you. Dr. Harry Wayne Parrish stated the attitude for the Board is we want to do all this I do not think anybody is against it but things just happen and definitely this area needs to be upgraded.
